What does the Fund invest in?


The Fund invests in high quality, value-priced common shares of primarily non-Canadian companies with an expectation for significant profit and dividend growth. The Fund may, at times, hold cash and/or equivalents while the Portfolio Manager seeks investment opportunities that meet its investment criteria.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Value Partners Investments Inc. has rated the volatility of this Fund as **medium.**

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees


Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how Series F units of the Fund have performed over the past 10 calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns. Past returns will not tell you how the Fund will perform in the future, particularly since the investment objectives of the Fund, as well as the portfolio manager of the Fund, changed effective November 1, 2011.

Year-by-year returns

This chart shows how Series F units of the Fund performed in each of the past 10 calendar years. The Fund dropped in value in 3 of the past 10 calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series F units of the Fund in a 3-month period over the past 10 calendar years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As at January 31, 2025, a person who invested \$1,000 in the Fund 10 years ago now has \$1,414. This works out to an annual compound return of 3.5%.



Who is this Fund for?

Investors who:

- · Are seeking growth in the value of your investments
- Are looking for a long-term investment
- Want to invest primarily in well-known US and foreign companies
- Can handle the ups and downs of the stock market

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much tax you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F units of the Fund. The fees and expenses - including any trailing commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You pay no sales charge at the time you invest in Series F units of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of December 31, 2024, the Fund's expenses were 1.20% of its value. This equals \$12.00 for every \$1,000 invested.

More about the trailing commission

There is no trailing commission paid on Series F units.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What You Pay	
Fee-based account units	Series F units are available only to investors who have fee-based accounts with a representative's firm that have executed an agreement with Value Partners Investments Inc. You will negotiate and pay a fee to your representative's firm for your account with that representative's firm. The fee may be paid by redeeming some of the units you own of the Fund on a quarterly basis.	
Short-term trading fee	2% of the value of units you sell or switch within 30 days of buying them. This fee goes to the Fund.	
Administrative fee	\$30 if your cheque is returned because of insufficient funds.	



What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days
- after you receive a simplified prospectus or Fund Facts document, or
 cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
