What does the Fund invest in?

The Fund focuses on the preservation of capital while investing in fixed income and equity securities that provide a reasonable level of income and the potential for long-term capital growth without any geographic restrictions.

The charts below give you a snapshot of the Fund's investments on May 31, 2022. The Fund's investments will change.

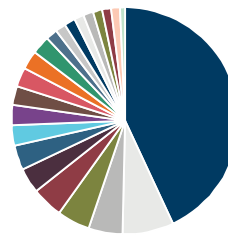

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

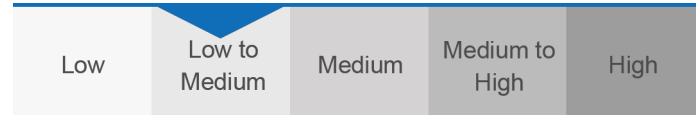
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Value Partners Investments Inc. has rated the volatility of this Fund as **low to medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

Year-by-year returns

Best and worst 3-month returns

Who is this Fund for?

Investors who:

- Are looking for a long-term investment
- Are seeking regular, but not fixed monthly income
- Want to invest in a mix of high quality bonds and equities
- Are comfortable with some fluctuations in the value of their investment

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much tax you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series O units of the Fund. The fees and expenses - including any trailing commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You pay no sales charge at the time you invest in Series O units of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. The Fund's expenses are made up of the management fee, operating expenses and trading costs. Investors who are permitted to purchase Series O Units will be charged a negotiated management fee which is paid directly to Value Partners Investments Inc. by the Series O investors and not by the Fund. No management fees are payable by the fund in respect of Series O Units. Series O Units are separately charged a Portfolio Management Fee of 0.15% of the value of Series O Units. Because this series is new, operating expenses and trading costs are not yet available.

More about the trailing commission

There is no trailing commission paid on Series O units.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What You Pay
Short-term trading fee	2% of the value of units you sell or switch within 30 days of buying them. This fee goes to the Fund.
Administrative fee	\$30 if your cheque is returned because of insufficient funds.
Advice and/or other services fee	No management fee or operating expenses are payable by the fund in respect of Series O units. Investors in Series O units pay a negotiated fee directly to Value Partners Investments Inc.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
