



This document contains key information you should know about VPI Sustainability Leaders Pool (the "Fund"). You can find more details in the Fund's simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

On June 13, 2023, it was announced that the shareholders of Value Partners Group Inc. (VPGI) (through a designated representative), Great-West Lifeco Inc. (Lifeco) and a wholly-owned subsidiary of The Canada Life Assurance Company (Newco) had entered into a share purchase agreement pursuant to which Lifeco and Newco will acquire VPGI, the parent company of Value Partners Investments Inc. (the Manager), the investment fund manager of the Fund (the Transaction). The Transaction will result in the indirect acquisition of the Manager. It is expected that the Transaction will close by the end of 2023. At the closing of the Transaction, it is expected that, subject to applicable approvals, there will be an internal restructuring that will result in Newco owning all of the shares of VPGI. The completion of the Transaction is subject to receipt of all required regulatory approvals, as well as satisfaction of the conditions of closing. No immediate material changes to the Fund are contemplated as a result of the Transaction.

What does the Fund invest in?

The Fund seeks to generate long-term growth in value by investing in equity securities of highly profitable and dominant global businesses with attractively valued share prices. The Fund focuses on investing in businesses who are making strong contributions to improving environmental and social outcomes for their industries and the communities they operate in, and in companies who benefit from a transition to a more sustainable future by creating products that help companies, countries, and others in having a positive environmental impact.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Value Partners Investments Inc. has rated the volatility of this Fund as **medium**.

Because this is a new fund, the risk rating is only an estimate by Value Partners Investments Inc. Generally, the rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how Series O units of the Fund have performed since inception. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This section tells you how Series O units of the Fund have performed in past calendar years. However, this information is not available because the Fund is new.

Best and worst 3-month returns

This section shows the best and worst returns for Series O units of the Fund in a 3-month period. However, this information is not available because the fund is new.

Average return

This section shows the value and annual compounded rate of return of a hypothetical \$1,000 investment in Series O units of the Fund. However, this information is not available because the Fund is new.

Who is this Fund for?

Investors who:

- are seeking growth in the value of their investments;
- are looking for a long-term investment;
- want exposure to equity securities of companies who benefit from a transition to a more sustainable future; and
- are comfortable with potential fluctuations of capital associated with investing in domestic and foreign equity markets.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much tax you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series O units of the Fund. The fees and expenses - including any trailing commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You pay no sales charge at the time you invest in Series O units of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. The Fund's expenses are made up of the management fee, operating expenses and trading costs. Investors who are permitted to purchase Series O Units will be charged a negotiated management fee which is paid directly to Value Partners Investments Inc. by the Series O investors and not by the Fund. No management fees are payable by the fund in respect of Series O Units. Series O Units are separately charged a Portfolio Management Fee of 0.20% of the value of Series O Units. Because this series is new, operating expenses and trading costs are not yet available.

More about the trailing commission

There is no trailing commission paid on Series O units.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What You Pay
Short-term trading fee	2% of the value of units you sell or switch within 30 days of buying them. This fee goes to the Fund.
Administrative fee	\$30 if your cheque is returned because of insufficient funds.
Advice and/or other services fee	No management fee are payable by the fund in respect of Series O units. Investors in Series O units pay a negotiated fee directly to Value Partners Investments Inc. Series O Units are charged a Portfolio Management Fee of 0.20% of the value of Series O Units.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
